## **Chappy's Outdoor Dining Expansion**

Commissioners reviewed a drawing which illustrated the location of the deck and surrounding area. She said the septic capacity and parking spaces may be a concern and should be looked at first before any application is submitted for site plan approval.

Mrs. Kaufer indicated the price charged for the engraved pavers may need to be adjusted since the public's interest in purchasing a paver has declined. She said the amount charged by Paverart, LLC is based on the number of brick pavers ordered. The Board Secretary reviewed pricing with the commissioners and they decided to not place an order until we reach a request for six bricks. It was

suggested to advertise the Honor Walk in the newspaper and also add a message in next year's calendar.
