After salute to the flag, Mr. Codner stated compliance with the Open Public Meetings Act.

MINUTES: A MOTION was made by Caiazzo seconded by Kaminski, to approve the minutes of the February 3, 2025 meeting. In favor, Kaminski, Caiazzo, and Codner.

Indian Fields:

Phase II As-Built Plans- Mr. Vreeland discussed the status of the receipt of the deliverables from Barberi and Associates for the Indian Field Phase II As-Builts. He stated that we have received the PDF As Built Drawing from Mr. Barberi. Mr. Vreeland stated they are currently reviewing the PDF files and should receive electronic copy once comments have been addressed.

WHEREAS, the Hardyston Township Municipal Utilities Authority (the "Authority") owns and operates a wastewater conveyance system servicing the residents of Hardyston Township (the "System"); and

WHEREAS, the Authority and MCI Eastern Security Systems, Inc. entered into an agreement for alarm services monitoring system (the "Agreement"); and

WHEREAS, on or about March 26, 2024, the Authority issued notice to the cancel the Agreement following its auto-renewal; and

WHEREAS, on or about April 4, 2024, MCI Eastern Security Systems, Inc. submitted a request to the Authority for payment of the outstanding cancellation fees; and

WHEREAS, after thorough consideration and deliberation, the parties have negotiated settlement terms leading to a mutually agreeable resolution; and

WHEREAS, in exchange for a full and general release from the Agreement, and subject to the waiver of all other claims against the Authority related to or arising from the facts and issues in dispute concerning the Agreement's cancellation, including attorney fees or other monetary relief, the Authority will provide MCI Eastern Security Systems, Inc. with a payment of \$6,000.00 (the "Settlement Amount") to resolve the matter; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of the Hardyston Township Municipal Utilities Authority as follows:

- 1. That the Authority hereby agrees and approves the terms of the Agreement, a copy of which shall be kept on file by the Authority's Clerk's Office.
 - b. Resolution Awarding the Bid for the Lease of Space on the Crystal Springs Water Tower for the Placement of Cellular Antennas and Related Equipment to Cellco Partnership, LLC (dba Verizon Wireless) and Authorizing Executive of a Lease Agreement

AND RELATED EQUIPMENT TO CELLCO PARTNERSHIP D/B/A VERIZON WIRELESS AND AUTHORIZING LEASE AGREEMENT PURSUANT TO AND IN ACCORDANCE WITH N.J.S.A. 40:12-14 et. seq.

WHEREAS, the Hardyston Township Municipal Utilities Authority (the "Authority") owns and operates a water supply system and wastewater collection system servicing a portion of the residents and businesses of Hardyston Township (collectively, the "System"); and

WHEREAS, the Authority desires to lease space on its Crystal Springs Water Tower located at Block 16, Lot 34 ("Crystal Springs Tank") for the installation of cellular antennas and related equipment; and

WHEREAS, N.J.S.A. 40A:12-14 authorizes a municipality to lease real property owned by the Borough not needed for public use, to a private person, if such lease is made to the highest bidder following public auction or the receipt of sealed bids; and

WHEREAS, the Authority, via an affirmative motion, dated on October 2, 2023, authorized a solicitation of bids in connection with the Work; and

WHEREAS, on January 3, 2025, the Authority received one bid submission in response to its solicitation, said bid result is attached hereto as **Exhibit A**; and

WHEREAS, Cellco Partnership d/b/a Verizon Wireless was determined to be the lowest responsible bidder; and

WHEREAS, the Authority has reviewed the bid submitted by Cello Partnership d/b/a Verizon Wireless and finds the proposed lease rate and terms contained in the bid to be acceptable by the Authority; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of the Authority as follows:

- 1. That Cellco Partnership d/b/a Verizon Wireless, with a bid price of \$4,141.00 per month for a maximum of twelve (12) antennas and \$150 per month for each additional antenna.
- 2. That the Administrator, working with the Authority's General Consulting Engineer and the General Counsel, is authorized to take all necessary actions and execute all necessary documents and agreements to effectuate the intent of this Resolution.
- 3. Notice of this Resolution and the contract award shall be posted in the appropriate newspapers and the Authority's website.
- 4. That this Resolution shall take effect immediately.

c. A MOTION was made by Kaminski and seconded by O'Grady to approve the Authorization to Permit the Township of Hardyston to Co-locate Emergency Communication Equipment on the Crystal Springs Water Tower and Park Drive Fire Suppression Tank . In favor: Kaminski, Caiazzo, Codner and O'Grady
