- For and in consideration of the use of the Wheatsworth Sports and Recreation Complex, the applicant agrees to save and hold harmless the Township of Hardyston, Hardyston Board of Education, its servants, agents, employees or any subdivision thereof, from any and all liability or costs arising out of the use of these Premises or Property by the applicant, the applicant's invitees, or other persons present at the time of the applicant's use of the premises.
- The applicant specifically agrees that this indemnification and HOLD HARMLESS AGREEMENT shall include the responsibility to provide legal defense for the Township of Hardyston and Hardyston Board of Education for any suit arising out of the applicant's use of the premises and that should the applicant's insurance carrier fail or refuse to provide such a defense, the applicant will reimburse the Township for any costs incurred by it for any person or organization acting on its behalf.
- Vendors will be responsible for any damage to designated area, property, or persons due to neglect or wrongdoing.
- Spaces must be reserved and paid in full before September 1, 2026. Fee is Non Refundable. We reserve the right to limit the number of businesses or groups in any particular category and work on a first come first serve basis.

### **FOOD VENDORS ONLY**

- All applications MUST include: a Food Handlers Permit from the Township of Hardyston, Temporary Retail Food Vendor Application through County of Sussex, as well as a copy of current Sanitary Inspection Certificate, and a Certificate of Insurance with minimum of \$1,000,000.00 naming "Township of Hardyston" as certificate holder.
- If you do not have a current Food Handlers Permit from the Township of Hardyston, please contact the Health Department at: 973-823-7020 x9453. **Additional fees may incur.**
- Any open flame for cooking, grilling, etc. requires a fire permit through Hardyston Township Fire Prevention Bureau.
- Retail Food Vendor Application with County of Sussex: Application is available on-line [www.sussex.nj.us](http://www.sussex.nj.us). Go to form center and proceed to Department of Environmental and Public Health Services - *Application: Farmers' Market/ Temporary Event Coordinator and Farmers' Market /Temporary Event Food Vendor List*
- Vendors will supply their own power source. Electric is NOT available.
